**A NEW ERA FOR THE LIGHT MILLENNIUM ~
CALL FOR TO NOMINEES FOR THE NEW TERM BOARD OF ELECTIONS

The Light Millennium (LM*, 2001, New York) Organization “received the approval” of the “Amended–and–Broadened” Certificate of Incorporation, and gained a new capacity towards becoming a ‘service’ and ‘rights-based’ organization, effective as of December 17, 2019.

2019 “AMENDED & BROADENED” CERTIFICATE OF INCORPORATION PUTS ITS CORE HUMAN DEVELOPMENT AS FIRST: Through “Amendment and Broadened” Certificate of Incorporation (initial 2001) of The Light Millennium, Inc., the Organization’s subtitle has been changed from “Multi-Media and Culture Organization” to “Charitable Global Human Advancement Organization” on December 17, 2019, which reflects well the core Purposes of the Organization, which is: “HUMAN ADVANCEMENT AS FIRST”.

SAVE THE DATE FOR SATURDAY, JUNE 18, 2022: The Light Millennium, Inc.’ 2001 By-Laws has been “Amended/Restated and Strengthen” on December 17, 2019, as well. With that, the Organization seeks to diversify, expand and strengthen its Governing Body through the New Term of Board of Elections (2022-2024). With the granted legal power through the 2019 “Broadened” Purposes/Mission along with the “Restated and Strengthen” By-Laws, the Organization’s Board of Directors has scheduled its first Annual Meeting and New Term Board of Elections based–on the latest legal changes– in New York City on **Saturday, June 18, 2022.** (Venue is to be determined.)

THE LIGHT MILLENNIUM IS IN A NUTSHELL: Officially formed in 2001, located in Queens, New York, online presence since August 1999. The Light Millennium (LM) Organization mainly has been focused on public awareness via multi-media platforms, has encouraged active participation from all walks of life and promotes the following matters within its capacity as a ‘rights based’ organization, based on its initial **2001 Certificate of Incorporation:** *Human Advancement, Democracy–Equality–Justice, Fostering World Peace, Freedom of Expression, Encouraging Intellectual Productivity, Girls–Women Rights, Cultural Diversity, Advancing Culture of Peace, and Global Connectivity...*

The Organization is a **non-religious, non-political, not-for-profit with #501c3 tax-exempt status, non-governmental (NGO), and non-member based an independent secular organization.** It publishes online issues, organizes public events, produces-and-presents television programs on the local channels (LMTV), and develops/presents in correlation with the United Nations’ *Vision and Programs* along with community-based various concepts in multi-platforms. Since the Covid-19 pandemic outbreak, the Organization has moved on to online-based webinars and public events.

The Light Millennium has been associated with the United Nations Department of Global Communications (formerly, Department of Public Information, UN-DPI) in December 2005. The LMGlobal.Org has sustained a “**good standing**” and “**active**” status since then. On an annual basis, the LMGlobal.Org can be presented at the United Nations with up to 6 representatives.
